## 4. First-Aid Measures

### 6. Accidental release measures

### **Personal precautions:**

Take appropriate protective measures. Clear area. Shut off source of leak only under safe conditions. Extinguish sources of ignition nearby and downwind. Ensure adequate ventilation. Wear suitable personal protective clothing and equipment.

### **Environmental precautions:**

Do not discharge into the subsoil/soil. Do not discharge into drains/surface waters/groundwater. Contain contaminated water/firefighting water. ### **Cleanup:**

## 7. Handling and Storage

### Handling
