General Information

MIRAGE® Blue WSB Lake & Pond Color is designed for use in lakes, ponds, decorative water features and other impounded bodies of water with limited outflow. MIRAGE® Blue WSB Lake & Pond Color beautifies murky, cloudy or off-color water with a pleasing natural aqua-blue tint.

Mixing Instructions

- Remove bag from outer plastic bag with a dry, gloved hand. Toss the bags into the lake or pond, spacing evenly in the water area. The most effective applications will be where the bags are placed in deeper water, or next to aerators or turbulent areas.
- Bags will begin to dissolve in three to five minutes (somewhat longer in colder waters), releasing MIRAGE® Blue WSB Lake & Pond Color.
- Dispersion of the color will depend on the movement of the water, but should occur within hours after treatment.
- Once color has been allowed to disperse completely, add bags, if needed, to maintain desired coloration.

Recommended Application Rates

- Determine the number of acre feet in the lake or pond. Surface area in acres
 [length (ft) X width (ft) / 43,560] times the average depth (ft) = Acre Feet. An
 acre foot is the area covering one surface acre, 12 inches deep.
- 2. **Apply one (1) bag per acre foot** or 1,234 cubic meters of water. For metric conversion to cubic meters, multiply acre feet by 1,234.

Directions for Water Use and Restrictions

- Water may be used for irrigation or fishing immediately following treatment.
- Allow several hours for MIRAGE® Blue WSB Lake & Pond Color to disperse before swimming.
- Do not apply MIRAGE® Blue WSB Lake & Pond Color to water used for human consumption.
- The diluted color in treated water will not stain exposed surfaces.
- The diluted color in treated water will not harm fish, waterfowl, pets or wildlife.
- Chlorinated water will cause color fading, requiring higher dosages or more frequent treatments
