

HERBI-OIL 83-17 SPRAY ADJUVANT

For use in combination with POAST[®] and other certain herbicides.

Principal functioning agents:

Paraffin base petroleum hydrocarbons 83%
Oil soluble surfactant blend17%

STATEMENT OF PRACTICAL TREATMENT

IF IN EYES: Flush with water for at least 15 minutes and get prompt medical attention. **IF ON SKIN:** Wash skin thoroughly with soap and water; remove and wash clothing before reuse. **IF SWALLOWED:** Dilute by giving water to drink and call a physician. Do not induce vomiting. Never give anything by mouth to an unconscious person.

INSTRUCTIONS

For use only as directed by the herbicide label, with those herbicides for which an oil based spray adjuvant is recommended. Unless otherwise indicated on the herbicide label, fill spray tank to 2/3 of the desired amount of water, add any emulsifiable materials, then HERBI-OIL 83-17 SPRAY ADJUVANT, and then wettable powders. Allow a mixing interval to completely mix each material between each addition of material. Then fill tank to desired level with continuous agitation. This product may be used with atrazine, Basagran[®], Blazer[®], Amine 2,4-D, Diuron, Evik[®], Fusilade[®], Poast[®], and Rescue[®].

For spot or small area treatments, a 1% solution of Oil Base Spray Adjuvant is suggested when in conformity with the herbicide label.

PRECAUTIONS

Use only in a well ventilated area. This product, when used with pesticides, may enhance skin absorption of the pesticide. Do not use with strong oxidizing or reducing agents, chlorate herbicides, ammonium nitrate or fertilizers containing ammonium nitrate, potassium nitrate, or sodium nitrate. Before making a selective herbicide application, test spray a small area to determine phytotoxicity to the desired crop, unless prior experience has proven safety to the desired crop under similar application conditions. Use with caution during periods of high temperature and high humidity, or when desired crop is under stress from lack of moisture or other cause. Keep container closed when not adding contents to spray tank.
