# **Section 4: First-Aid Measures**

**If in Eyes:** Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.

**If Swallowed:** Call a poison control center or doctor immediately for treatment advice. Rinse mouth with water and have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious or convulsing person.

**If on Skin or Clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes.

# Section 7: Handling and Storage

#### Personal Protection:

**Eye/Face Protection:** Wear safety glasses with side shields or chemical splash goggles to prevent vapors or mists from entering the eyes. If using a full face shield, always use safety glasses or goggles along with the face shield to ensure adequate protection of the eyes.

**Skin Protection:** Use protective clothing chemically resistant to this material. Selection of specific items such as face shield, boots, apron, or full body suit will depend on the task. Safety shower should be located in immediate work area. Remove contaminated clothing immediately, wash skin area with soap and water, and launder clothing before reuse or dispose of properly. Items which cannot be decontaminated, such as shoes, belts and watchbands, should be removed and disposed of properly.

**Hand protection:** Use gloves chemically resistant to this material. Examples of preferred glove barrier materials include: Neoprene, Nitrile/butadiene rubber ("nitrile" or "NBR") or Polyvinyl chloride ("PVC" or "vinyl").

**Respiratory Protection:** Respiratory protection should be worn when handling in enclosed areas, when large quantities of mists are generated or prolonged exposure is possible. Use a respirator with either an organic vapor-removing cartridge with a pre-filter approved for pesticides (MSHA/NIOSH approval number prefix TC-23C) or a canister approved for pesticides (MSHA/NIOSH approval number prefix TC-14G).
