## **Section 4: First-Aid Measures**

Have the product container or label with you when calling a poison control center or doctor, or going for treatment.

**Eye Contact:** Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes for at least 15 minutes.

**If Swallowed:** Call a poison control center or doctor immediately for treatment advice. Rinse mouth with water then have person sip a glass of water if able to swallow. # **Section 5: Fire Fighting Measures**

**Eye/Face Protection:** Wear safety glasses with side shields or chemical splash goggles to prevent vapors or mists from entering the eyes. If using a full face shield, always use safety glasses or goggles along with the face shield to ensure adequate protection of the eyes.

**Skin Protection:** Use protective clothing chemically resistant to this material. Selection of specific items such as face shield, boots, apron, or full body suit will depend on the task. Safety shower should be located in immediate work area. Remove contaminated clothing immediately, wash skin area with soap and water, and launder clothing before reuse or dispose of properly. Items which cannot be decontaminated, such as shoes, belts and watchbands, should be removed and disposed of properly.

Use a respirator with either an organic vapor-removing cartridge with a pre-filter approved for pesticides (MSHA/NIOSH approval number prefix TC-23C) or a canister approved for pesticides (MSHA/NIOSH approval number prefix TC-14G).

**Ingestion:** Avoid ingestion of even very small amounts; do not consume or store food or tobacco in the work area; wash hands and face before smoking or eating.
