# 2. Hazards Identification

## **Emergency overview**

# 4. First-Aid Measures

### General advice:

First aid providers should wear personal protective equipment to prevent exposure. Remove contaminated clothing. Move person to fresh air. #### If swallowed:

Never induce vomiting or give anything by mouth if the victim is unconscious or having convulsions. Do not induce vomiting. Have person sip a glass of water if able to swallow.

# 5. Fire-Fighting Measures

## **Environmental precautions:**

Do not discharge into the subsoil/soil. Do not discharge into drains/surface waters/groundwater. Contain contaminated water/firefighting water. ## Cleanup:

# 7. Handling and Storage

# Handling

## General advice:

### **Respiratory protection:**

Wear respiratory protection if ventilation is inadequate. Wear a NIOSH-certified (or equivalent) organic vapour/particulate respirator.
